### **III. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE**

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

#### **Home athletes**

Home athletes, will be invited by the Organising Committee, following consultation with the Swiss NF – SVPS; the number of horses per home rider (maximum 3) will be determined, in consultation with the Swiss NF – SVPS/FSSE.

The Longines Rankings number 189, established three (3) months prior to this Event, will be used for the invitation of athletes (applicable for CSI2\*/CSI3\*/CSI4\*/CSI5\* events worldwide). Athletes are invited by the Organiser through their National Federation in accordance with the CSI Invitation Rules (refer to Jumping Rules Annex V).

Athletes are invited by the Organiser through their National Federation in accordance with the CSI Invitation Rules (refer to Jumping Rules Annex V). Following implementation of the FEI online Invitation System, the invitation of athletes from the top of the Longines Rankings will be fully automated. For CSI2\*-5\* events where the total number of athletes invited is restricted, invitations will be automatically issued in three phase cycles to all athletes having the right to participate based on their position in the Longines Ranking, and to their NFs, until the closing date for entries of athletes selected from the top of the Longines Ranking.

#### **Grooms**

One (1) groom per athlete only.

#### **CSI-Am cat A+B**

The CSI-Am cat A+B Basel – 2017 will be open only to athletes invited. The Organizing Committee will invite – through their respective NFs – a limited number of amateur athletes, up to a maximum of 115 horses to participate in the events CSI-Am competitions, according to the following specification:

NFs invited:	AUT, ESP, FRA, GBR, GER, GRE, ITA, POL, SUI, SWE and USA
Reserve NFs:	BEL, DEN, FIN, IRL, NED, NOR and POR

Number of horses per athlete:	2   minimum 6 years of age for category B and minimum 7 years of age for category A

The following additional conditions will apply to the CSI-Am Cat. A+B Basel – 2017:

1. Entries will be accepted at a first come, first serve basis; the Organising Committee reserves the right to close the entries even before the deadline date of December 22<sup>nd</sup> 2016, if the maximum number of entries ( $\pm$  115 horses) will be achieved, prior to the date concerned;
2. Per athlete a maximum of one groom only will be accredited; all athletes and grooms will stay at the event at their own expense. Requests for accommodation must be sent with the definite entries;
3. Athletes competing in the CSI-Am classes, are not eligible for participation in any competition of the Longines CSI 5\* Basel – 2017;
4. Each horse may compete in one competition of the CSI Am Cat A+B Basel - 2017 per day only, with the exception of competition N° 13; horses having competed in competition N° 11 or N° 12 will be eligible for participation in competition N° 13 as well;
5. At the time of declaration of their horse(s), athletes must point out in which competition they will participate; athletes may shift their entries between category A and B on separate days during the event, if so desired, providing the horse is eligible for the category concerned;
6. Per competition an athlete may compete with a maximum of two horses;
7. In case of a tie for any place, the prize money will be added and be divided equally;
8. Unless stated otherwise in this particular section, all rules and conditions of the official schedule of the Longines CSI Basel – 2017 will fully apply to the athletes, competing in the event's CSI-Am competitions;
9. Simply by entering a horse into the CSI Am Cat A+B Basel - 2017, the Person Responsible fully accepts the conditions of the schedule and of the program itself, applicable for the athletes, grooms and the horses.

The postponement or abandonment of the show either before the opening or at any time during the course of the show shall not give rise to any claim whatever against the show or the Organising Committee by the competitors or others except for refund of prepaid entries in respect of classes or competitions not held. In the case of postponement refund will only be made in respect of entries duly withdrawn.

**Important**

Any official entry of a horse for this event automatically and unconditionally entails:

1. the formal and unconditional approval of the horse owner(s) concerned, regarding his/her horse(s)' presence at and participation in the Longines CSI Basel – 2017;
2. the athletes agreement without limitation for himself and for his representatives to be bound by the FEI rules and the conditions listed in this official schedule, including its liability clauses;
3. the athletes understanding that the Longines CSI Basel – 2017 is governed by Swiss law and if there is any suspicious incident, the proper authorities will be involved to handle the situation.

The Organising Committee may at their absolute discretion with Ground Jury approval, remove any person or animal from the event without being liable for any compensation. No decision will however be taken by the Organising Committee relating to athletes and/or horses participating in international competition without previous Ground Jury approval.

- In both qualifying competitions N° 02 and N° 06 (category A) points will be awarded as follows: the athlete placed first gets 100 points; the second placed athlete gets one point less etc.;
- If an athlete competes with two horses, the highest number of points per day will be counted for qualification purposes only;
- In case of equal placing in the qualifying competitions, all respective athletes will receive the points corresponding to their placing;
- Athletes eliminated or having retired in the qualifying competitions will receive no points; this however does not apply to an elimination or a retirement during the second phase of competition N° 06 or N° 07.

### **Starting order**

The starting order for the first round will be according to the reverse order of qualification system's result. In case of equality of points, the starting order of the athletes concerned will be established by a separate draw.

### **Substitution**

In case one of the 25 athletes eligible for participation withdraws from this competition, he/she may be substituted by the next best placed athlete, according to the qualification results. In any case the deadline for substitutions however is Saturday January 14<sup>th</sup> 2017 | 10hrs30 am.

Moreover all substitutions will require the Ground Jury Presidents approval in writing to be valid at all. A new athlete will be placed in the starting order for the first round in the same position, allocated previously to the athlete he/she will be substituting.

- For each horse coming into Switzerland from abroad the following documents must be provided:
1. An international FEI-passport or a national passport, approved by the FEI;
  2. A health certificate for trade between members states of the EEC and Switzerland;
  3. A carnet ATA, issued and approved by the local Chamber of Commerce. Value per horse min. EUR 20'000.--. The carnet has to be opened by the customs in your country or temporary Import and Export over Basel/Weil am Rhein. The caution will be paid by the forwarding agent (Brändlin Sped AG). For the clearance we only need one diagram per horse and the truck registration number, but you have to fax the details to the local Chamber of Commerce. Value per horse min EUR 20'000.--. The carnet has to be opened by the customs in your country;

Athletes must arrange their own transportation of horses and are moreover responsible for arranging correct custom formalities. Customs clearance is made at the stables on the show grounds.

The horse boxes have to travel under transit bond directly to the stables on the event venue in Basel. The Swiss customs authorities have instructed all customs offices at the Swiss border accordingly. All costs arising from not following these instructions will be for the account of the competitor(s) concerned.

#### Attention

Since 1995 the custom regulations between EU and EFTA apply. All foreign competitors are strongly requested to strictly follow the above formalities. In case documents are found to be not in order, horses risk to be stopped at the border. ## **3. NATIONAL REQUIREMENTS**

For each horse coming into Switzerland from abroad the following documents must be provided:

- a) An international FEI-passport or a national passport, approved by the FEI;
- b) A valid health certificate, issued by the official veterinary authority in the country of origin;
- c) Non EU competitors are strongly advised to use an ATA carnet, issued and approved by the local Chamber of Commerce. The carnet has to be opened by the customs in your country.

## **4. PONIES**

FEI Veterinary Regulations, Chapter IV:

For all Pony Events, Ponies must be available for Pony Measurement if requested by the FEI.

## **5. INJURY SURVEILLANCE**

FEI Veterinary Regulations, articles 1036, 1039 and 1040:

Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post mortem examination.

## **6. TRANSPORT OF HORSES**

Horses must be fit to travel and be transported in suitable vehicles for the transport of horses. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the

responsibility to comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

**7. VENUE ARRIVAL INFORMATION & FITNESS TO COMPETE**

**7.1. PASSPORTS. FEI General Regulations Article 137**

**For all issues relating to FEI Horse Passports/FEI Recognition Cards please contact your National Federation.**

All Horses competing at FEI Events must be registered with the FEI.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses entered in CIMs, in CSIP or in CSICH Cat. A in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (GRs 137.2).

Athletes who do not present a Horse’s Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex II of the FEI Veterinary Regulations** and may not be allowed to compete.

**NB** for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

**7.2. VACCINATIONS - EQUINE INFLUENZA. FEI Veterinary Regulations Article 1028**

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the

relevant territory

### **7.3. EXAMINATION ON ARRIVAL. FEI Veterinary Regulations Article 1032**

On arrival at an Event venue, all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

### **7.4. HORSE INSPECTIONS. FEI Veterinary Regulations Article 1033, Table 2**

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

### **7.5. LIMB SENSITIVITY EXAMINATION. FEI Veterinary Regulations Article 1034**

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event, including, but not limited to, between rounds and before the Jump Off. Horses may be examined once or on multiple occasions during the Period of an Event.

Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

## **8. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP). FEI VETERINARY REGULATIONS, CHAPTER VI**

### **8.1. SAMPLING. FEI VETERINARY REGULATIONS ARTICLES 1057 AND 1058**

All horses competing at FEI Events may be subject to sampling for the presence of FEI Equine Prohibited Substances in accordance with the FEI Equine Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to Chapter VII, paragraph 3 for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

### **8.2. ELECTIVE TESTING. FEI VETERINARY REGULATIONS ARTICLES 1056**

Elective Testing may be carried out prior to an Event to check for the presence of prohibited substances. Please refer to <http://inside.fei.org/fei/your-role/veterinarians> for information and details.

## **XII. HUMAN ANTI-DOPING**

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEI's Anti-doping Rules for Human Athletes (ADRHA).

The ADRHA rules are published on the FEI website at <http://inside.fei.org/content/anti-doping-rules>.

## **XIII. ADDITIONAL INFORMATION**

### **1. INSURANCES AND NATIONAL REQUIREMENTS**

Equestrian sports involve inherent dangerous risks. To the greatest extent permitted by law, the FEI and the FEI Event Organiser shall NOT be liable for any damages relating to loss of property or injury of any kind to Athletes, Owners, Support Personnel or Horses at or in connection with an FEI Event and the FEI expressly excludes all such liability.

#### **1.1. ATHLETES, OWNERS AND SUPPORT PERSONNEL**

##### **1.1.1. Personal Accident and Health Insurance**

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

##### **1.1.2. Personal Property Insurance**

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

#### **1.2. ATHLETES AND OWNERS**

##### **1.2.1. Third Party Liability Insurance**

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

##### **1.2.2. Additional Liability Information**



The Organising Committee will not accept responsibility for any accident happening to owners, participants, grooms, to or because of their horses to third parties in whichever circumstances, inside or outside the show grounds, during, before or after competitions. The civil and financial responsibility of the Organising Committee and its co-operators will never be liable in any circumstance.

The Organising Committee (including their employees, representatives and show officials) will not be responsible for any accident, injury or damage that may occur to, or any illness or disease which may be contracted by any horse entered at the Longines CSI Basel – 2017 however occurring, and the Athletes and Horse Owners shall keep the Organising Committee indemnified against all liability whatever arising from any accident, injury, damage, illness or disease.

Athletes recognize and accept that all equestrian sports involve inherent risks and that no helmet or protective equipment can protect against all foreseeable injury. Consequently, by entering their horse(s) for Longines CSI Basel – 2017 they accept the risk and hold harmless the Organising Committee, the FEI, the officials, agents, employees and their representatives.

The Organising Committee will not be in any way liable for anything that may happen (from any cause or circumstances whatever) to property brought into the event or for any other loss, claim, circumstance, matter or event whatever in connection with, or arising out of, or attributable to the actions of the Organising Committee (including their employees, representatives and show officials) or any of their officers, or agents or these or any other rules or regulations special conditions prescribed by the event.

### **1.2.3. Horse Insurance**

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

## **2. PROTESTS/APPEALS**

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF 150.- or equivalent.

## **3. SCHOOLING DURING COMPETITIONS**

Athletes wishing to school during speed competitions (Table A and Table C) must inform the OC before these competitions begin. These athletes will start first in these competitions.

## **4. STEWARDING**

- If an athlete is uncertain as to whether the boots he/she intends to use during an event are allowed, he/she or his/her representative should show the boots to the Chief Steward for his/her opinion before the boots are used in training or in competition.
- In addition, athletes are to be made aware that hind boots must be removed and placed again on the horse's legs in the presence of a Steward while in the warm-up arena prior to entering the competition arena for certain competitions. (If bandages are used in place of boots, athletes are not required to remove the bandages in the warm-up arena.) This procedure is compulsory for competitions for which boot and bandage control is mandatory, that is the Nations Cup, Grand Prix, and the competition with the highest prize money, and is at the discretion of the Chief Steward for other competitions.
- As an alternative to carrying out this procedure at the time designated by the Steward an athlete may ask his/her groom to take the boots to the in-gate and place them on the horse's legs in front of the Steward prior to the combination entering the arena.
- The Steward has the authority to intervene if a boot is deemed excessively tight by instructing that the boot be removed and put on again correctly. *[Stewards are to note that it is normal for a horse's gait to be somewhat affected immediately after boots have been removed and re-placed.]* If an athlete or his/her groom refuses to remove and re-place the boot(s) when instructed to do so by the Steward, a Yellow Warning Card will be issued to the athlete in question.
- If it is deemed impossible or unsafe to remove the hind boots in the warm-up arena prior to the combination entering the competition arena, due to an extremely excited or nervous horse, the boots of the horse in question are to be removed by the athlete/groom following the athlete's round upon leaving the arena and inspected by the Steward. This inspection may be carried out during the boot and bandage control if the boot and bandage control is carried out for the competition in question.
- This procedure does not replace boot and bandage control after completion of an athlete's round for competitions for which boot and bandage control is mandatory (refer to JRs Art. 244.1).

## **5. DISPUTES**

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

## **6. MODIFICATION TO SCHEDULE**

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate, the President of the Ground Jury or the Foreign Judge, as applicable.

## **7. ADDITIONAL INFORMATION FROM THE OC**

### **A. SHORTENING/CANCELLATION**

The Organising Committee reserves the right to take all necessary action, including cancelling or shortening the Longines CSI Basel – 2017, due to special and/or unforeseen circumstances, which in the opinion of the Organising Committee, would make the continuation of the event unjustified. Any such decision will be taken in agreement with the Secretary General of the FEI. No consequential liability whatsoever can be accepted in such occasion. Gen. Reg. 115.1 and 115.2.

**B. START & RESULTS LISTS**

The name of the owner of each horse will be added to all start lists and result sheets, as well as its stud book initials, country of birth, sex and age.

**C. DECLARATIONS**

With the exception of the competitions No 4 and No 5 on Thursday 12th January 2017, no horse will be allowed to start in more than one competition per day. Each individual athlete is allowed to compete with one horse only in each competition. Moreover, no horse will be permitted to compete in any competition, unless the declaration has been made within the deadline specified down below, i.e.:

- a) Horses participating in the competitions on Thursday (January 12th, 2017) must be declared at the secretary's office, immediately following the official Horse Inspection on Wednesday (January 11th 2017) but in any case at 17hrs30 at the latest for the CSI-Am competitions and at 19hrs00 at the latest for the CSI 5\* competitions;
- b) Horses starting in the competitions on Friday (January 13th 2017), on Saturday (January 14th 2017) and on Sunday (January 15th, 2017) must be declared on the night before at the secretary's office, at the latest 30 minutes after the prize giving ceremony of the last competition of the previous day.

**D. SUBSTITUTION**

After declaration no substitution of horses will be permitted, unless the Event's Treating Veterinarian certifies officially, that the declared horse has become unfit to compete since the time of declaration. The final decision about the substitution is however at the discretion of the Ground Jury, following consultation of the FEI Veterinary Delegate.

**E. PRACTICE ARENA**

Training (including working, lunging and walking) of horses is only allowed at specified times on the official and controlled exercise areas, provided by the Organising Committee from Wednesday January 11th 2017 (immediately after the Horse Inspection), until the conclusion of the event on Sunday, January 15th 2017.

The exercise / practice areas will be permanently supervised by FEI stewards. During a competition the exercise/practice area is strictly reserved to horses starting in the present competition and the next three athletes must be mounted and ready to enter the arena.

If an athlete is not ready when his/her starting number/name is called, he/she will lose his/her place in the starting order and he/she will be eliminated from that competition at the discretion of the Ground Jury, unless certain circumstances prevent this (e.g. losing a horse shoe just before his/her turn to start).

**F. IMAGE RIGHTS**

The Organising Committee reserves the right to use – without any compensation due – photographs, videos or any other digital registered picture from athletes and/or horses, made or registered during the Longines CSI Basel – 2017, for promotional and/or marketing purposes, related to the event.

It is a condition of entry that all athletes will permit any photographic or filmed material derived during the course of the event, to be utilised subsequently by the Organising Committee for future promotion of their business interests or the show, at no cost to the latter.

Moreover the Organising Committee would highly appreciate the athletes' co-operation for marketing activities related to the event (for example to join a meet and greet session with main sponsors), for approximately 20 minutes maximum, if so requested.

**G. INCIVILITY**

Any act of discourtesy or disobedience to any judge, steward or any show official on the part of the athlete, groom, driver or owner of a horse may – at the discretion of the President of the Ground Jury – result in the athlete's horses being disqualified from the event, in which case (entry) fees and prize money won will be forfeited.

**H. PARADING**

All horses must be paraded whenever so ordered by the Organising Committee or an authorised show official. Any failure to comply with this rule may result in disqualification from competing and forfeiture of prizes, at the discretion of the Ground Jury.

**I. DOCTOR | MEDICAL SERVICE | FARRIER**

Veterinary and medical assistance, as well as farriery services, are available for the duration of the event. These services are at the expense of those requesting them.

When, in the opinion of the Show's veterinary surgeon, a horse is so severely injured that it ought to be humanely destroyed, the Person Responsible should where possible first be informed.

However, the Show's veterinary surgeon may proceed with humane destruction, without reference to the PR, in order to prevent undue suffering to the horse. Before taking this action, the Show's veterinary surgeon should, wherever practicable, seek a second veterinary opinion. In such eventuality, owners are responsible for the cost of disposal.

**J. PRIVATE VETERINARY SURGEONS**

Private veterinaries will have to report to the FEI Veterinary Delegate upon their arrival at the show grounds, before they will be accredited and be allowed to enter the restricted area. Under no circumstance will any veterinary surgeon other than the FEI permitted Treating Veterinarian be allowed to treat any horse at the Longines CSI Basel – 2017, unless permission in writing has been received from the FEI Veterinary Delegate.

**K. STABLING**

All horses, entered for the competitions of the Longines CSI Basel – 2017 must be stabled in the official stables provided by the Organising Committee (immediately after the official Horse Inspection) for the entire duration of the event. They are not to be removed between the dates of Wednesday January 11th, 2017, following the first official horse inspection, and the last competition on Sunday January 15th, 2017, in accordance with the relevant FEI rules.

**L. NO SMOKING POLICY**

Smoking inside the stables is strictly prohibited; offences against this rule, first will incur a fine and in case of a repeated offence, will lead to permanent exclusion from the stables by means of withdrawal of the accreditation of the person concerned.

**M. EMERGENCY STABLE CARDS**

ECSCs will be available in the stabling area. It is the responsibility of the rider/groom to complete the card in full and affix to their horses stable door for the duration of their stay at the show. Whilst every reasonable effort will be made to contact the owner/person responsible of the animal, if unsuccessful the Veterinary Surgeon on duty will treat the animal as he finds necessary.

**N. IDENTIFICATION**

For identification purpose all horses stabled must carry their identification number whenever leaving the stables; offences against this rule, will incur a fine.

**O. HEALTH DOCUMENTS**

Foreign athletes requiring health documents for their horses to facilitate their onward journey following their sojourn at the Longines CSI Basel – 2017, must inform the secretary's office accordingly not later than Thursday January 12th 2017, by 15hrs00.

**P. DOGS**

Dogs must be kept on a leash at all times; offences against this rule may lead to permanent withdrawal of the accreditation of the person concerned.

**Q. ORGANISING COMMITTEE**

The organizer referred to in this schedule shall mean « CSI Basel Horse Event AG » and will in this document be referred to as the Organising Committee.

**R. GENERAL**

Competitors and others involved in the Longines CSI Basel – 2017 must make themselves conversant with this official schedule's content, in addition to the special conditions applicable to the various competitions.

Riders may only compete on the understanding that they comply with and are bound by these regulations and the special conditions relating to each competition. Simply by entering a horse into the Longines CSI Basel – 2017, the Person Responsible fully accepts the conditions of the official schedule and of the program itself, applicable to the athletes, grooms, horse owners and the horses.

In case of a tie for the 12<sup>th</sup> place in a competition with 12 to 48 starters, the prize money foreseen for the 12<sup>th</sup> place will be divided equally among the athletes concerned.

**For Competitions run in two rounds with more than 12 starters in 2<sup>nd</sup> round:**

OCs that indicate in the schedule that a specific number (that is more than 12) of athletes will return for the second round will be permitted to distribute the prize money for that competition among all the athletes taking part in the second round, even if the second round is followed by a jump-off in case of a tie on penalties for first place after the second round.



**DEDUCTIONS FROM PRIZE MONEY AT COMPETITIONS:**

**Full details of any deductions from prize money must be outlined in the schedule. This includes government taxes. If it is necessary for Organisers to deduct such taxes, they must provide participants with an official form indicating the amount of tax deducted.**

**The tax form must be provided to the athletes upon arrival and returned to the Organiser prior to departing.**

Foreign athletes are taxable in Canton Basel Land | SUI by 15% tax deduction on money prizes won; the Organising Committee will deduct taxes from prize money won immediately. Athletes will be provided with an account, indicating the amount of tax deducted.

In all cases, athletes will be invited to provide all necessary information, in order to guarantee the correct tax procedure; to this purpose all athletes must provide the Organising Committee with a copy of the relevant pages of their passport and their home address. Every athlete is responsible for the correctness of the details he/she submits.

**PRIZE MONEY TRANSFER**

Prize money will be paid on Sunday January 15th 2017, after the last start of the competitor in CHF. The scheduled prizes are gross amounts. Up to an amount of CHF 500,-- maximum, prize money will be paid by the Organising Committee in cash to the athlete concerned. If the amount of prize money won exceeds the maximum mentioned above, prize money will be transferred to the athlete's bank account within two weeks following the closure of the event.

**IMPORTANT**

**The total amount of prize money shown for each Competition in the schedule must be distributed. (FEI General Regulations articles 127 and 128)**

For details of the prize money breakdown for each competition please refer to the tables at the end of this document; the Organiser must specify which of the two (2) tables will be used. The total prize money for the Competition must be distributed among the first twelve (12) placed athletes.

The Organiser must provide additional created prizes for athletes placed beyond twelfth (12<sup>th</sup>) place. The minimum amount for each of these additional prizes, for athletes placed from thirteenth (13<sup>th</sup>) to last place, must be clearly specified in the approved schedule and not exceed the prize money of the athlete placed twelfth (12<sup>th</sup>)

**IMPORTANT**

\*: Maximum Number of starters per competition: 100.

If more than 100 starters are declared, the OC must split the class and provide the equivalent amount of prize money for the additional Competition. OCs may apply either of the following methods for splitting the Competition:



---

The competition is split into two groups before it starts. There may be a different number of starters in each group. There may be athletes with multiple horses in each group but all horses of any one athlete must be in the same group.

OR

The competition is run as one single competition and split afterwards into two groups and the classification established as follows: the athlete with the best score is the winner of the first group, the athlete with the second best score is the winner of the second group and so on until prizes have been allocated to 25% of the total number of starters. *NB: In this case separate results must be sent to the FEI for each of the two groups, e.g. results for Competition 1a and for Competition 1b.*

In both cases above each group must offer the same amount of prize money as indicated for the original Competition. For the avoidance of doubt, it is the number of declared starters in the Competition, not the actual number of starters, that determines whether the Competition must be split.
